**Policies – Video Camera Updates – CPCA and also Post C are collaborating for a model policy for video body cameras. The Westport Police Department is currently doing a pilot program they have been given Taser Body Cameras. The Chief spoke to the company that manages our servers, if Weston was to use body cameras we would set up a separate server and the equipment could be downloaded on docking stations, it would date it, time it and the Officers badge # would be assigned to that camera and all of the information would be stored on our server.**
