Annual Town Budget Meeting (ATBM):

Wednesday, April 19th

At the conclusion of the meeting, Adjourned Referendum voting will commence in the Weston High School Library. ***Adjourned Referendum voting will continue on Thursday, April 27th at the Town Hall Meeting Room from 12:00 PM to 8:00 PM***

Persons eligible to vote at the ATBM must be an elector of the Town of Weston or a citizen of the age of eighteen years or more who, jointly or severally, is liable to the town, for taxes assessed against him on an assessment of not less than one thousand dollars (\$1,000) on the last completed Grand List of Weston, or who would be liable if not entitled to an exemption.

Absentee ballots will be available through the Town Clerk's Office starting on Thursday, April 20th. In order to be counted, ballots must be received back by the Town Clerk no later than Thursday, April 27th.

Registration Deadlines:

ATBM and April 19th voting: Voter registrations received by mail, online or in person by 12:00 noon on Wednesday, April 19, 2017.

Adjourned Referendum April 27th voting: Voter registrations received by mail, online or in person by 4:00 pm on Wednesday, April 26, 2017.

VOTER REGISTRATION

Eligibility Requirements:

- U.S. citizen
- Resident of Weston
- At least 17 years of age (as long as you will turn 18 by Election Day)
- Completed confinement and parole, if previously convicted of a felony

ABSENTEE BALLOT INFORMATION FOR ADJOURNED REFERENDUM

Any qualified registered voter may vote absentee **ONLY** if unable to vote in person due to:

- Illness or physical disability
- Absence from town during all voting hours
- Religious beliefs which forbid secular activity on days of Adjourned Referendum voting
- Active U.S. military service
