**MINUTES**

**Meeting called to order at 7:30 PM**

**Commissioners Present:** Rick Phillips, William Brady, Beth Gralnick, John Hamerslough, Peter Ottomano, Jeff Eglash and Jess DiPasquale.

**1) Consideration/Approval of the minutes of the Special Meeting of October 1, 2009.**

Motion from Commissioner Gralnick to approve minutes with revisions, seconded by Commissioner Brady. All in favor.

**2) Presentation of Chief's report for October, 2009—Chief Troxell**

Overtime for the month of October 2009 was over \$20,377.00, Chief Troxell explained the circumstances causing the overtime. There is approximately \$20,000.00 left over from Officer Palmiero's salary to be put into overtime. A grant for \$61,000.00 less \$15,000.00 will be coming in.

**3) Discussion of request for temporary stop signs at Lyons Plain Road and North Avenue/Cedar—John Conte, Joe Lametta**

A letter received from Nancy Tenenbaum and Michael Scavone regarding the traffic in front of their house at the intersection of North Avenue and Lyons Plain Road was entered into the minutes. Ms. Tenenbaum and Mr. Scavone would like something done with regards to the sightlines, the intersection the speeding on Lyons Plain Road. Mr. Conte, Town Engineer, stated that there was nothing wrong with the sight line but would speak to Mr. Lametta asking that the undergrowth be cut back. Mr. Conte is to look into options for Lyons Plain Road.

**4) Update on Godfrey Road/Ravenwood Intersection Improvement—John Conte**

Mr. Conte stated that the stop sign on Ravenwood Road needs to be repositioned, an Intersection Ahead sign would be put on Ravenwood Road and warning signs to be put on Godfrey Road would be installed on Thursday November 11, 2009. The survey of Ravenwood Road and Godfrey Road is to be done on Thursday. Site line improvement will then be given to the homeowner, Hal Hutchinson. He must also get the cost of the project submit it to the Board of Selectmen for their approval.
