### RECORDING FEES FOR DEEDS TRANSFERRING PROPERTY

\$70.00 for the first page and \$5.00 each additional  
An additional transfer fee of \$2.00 on any sale of real estate for consideration  
Town Conveyance Tax computed at 1/4% (.0025) of the total sale price  
State Conveyance Tax computed at 3/4 (.0075) of purchase price up to \$800,000  
Any amount over \$800,000 is computed at 0.125  
A State of Connecticut Conveyance Form must accompany the recording
